Don't miss this opportunity to be where perspectives connect, ideas converge, and the industry comes together in alignment for what is next of Malaysia's investment landscape.

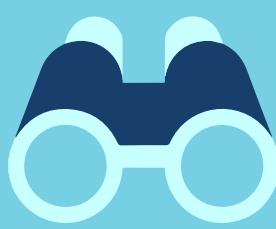
